SAFETY GUIDELINES:

Our #1 Priority for Parade Entries and Spectators

- **Floats:** Shall not exceed 14 feet in height in order to clear any obstacles, such as traffic lights, trees, etc., along the parade route.
- **Vehicles:** Miscellaneous (standalone) vehicles will be allowed if they are a "special interest" vehicle of some kind, such as an antique or classic car. The entry must be decorated in a patriotic fashion.
- **Riders:** Those on a float/entry are not permitted to get on and off the float/entry throughout the parade.
- **Out Walkers:** Clowns and other costumed out walkers are encouraged to add energy and originality to parade.
- **NO WALKING VENDORS:** We encourage the promotion and advertising efforts of your business/organization, but if you would like to promote your business/organization, you will have to pay for a commercial entry.
- **Campaigning:** Those campaigning for upcoming election are welcomed to participate as a commercial entry. Following the parade, it is highly encouraged for you to mingle with those at the Porter Park festivities.
- **Weaving on Street:** [Cautious] side to side weaving is allowed. For your safety and the safety of the public, 360° movement of entries is prohibited. All entries are to be moving forward throughout the entirety of the parade. This prohibits any backwards movement.
- **Clean Up:** Please be considerate and clean up any discarded refuse caused by your entry.
- **Indemnification:** All participants assume risks associated with participating in the parade and agree to indemnify the Rexburg Area Chamber of Commerce for any damage, injury, or claims occurring due to their participation.

Throwing of candy/bling/favors, or passing of fliers is only allowed by those walking next to their float/entry.

Those on a parade float/entry are prohibited from throwing any items. If there is photo evidence of this occurring, a \$100 violation fee will be charged to your entry. Keeping children out of the street and parade path is of the utmost importance!

GENERAL PROCEDURES AND GUIDELINES:

- **Decision of Committee:** The Independence Day Parade Committee will review every entry as it fits within the goals and guidelines of a safe and enjoyable 4th of July celebration. If you do not hear from the parade committee within 5-7 days after submission, you may assume your entry has been accepted.
- **Parade Assignment:** A MANDATORY meeting will be held in June of 2024. If you are unable to attend the meeting, there may be adjustments with your entry. Verify your contact information is correct to receive further updates.
- **Refunds:** There will be no refunds for entries after Thursday, June 27, 2024 (1 week before parade).
- **Zoning:** No entry will be allowed in the parade if it is not lined up in its assigned parking spot in its correct zone, and at the correct time. You will receive instruction about this at our mandatory meeting.
- **Unique Directives:** Special rules may apply to your entry. If so, you will be contacted after your application submission.
